Approve Meeting Minutes

The minutes of the April 16th, 2008 meeting of the Directors were reviewed. After a motion duly made and seconded, the minutes of both meetings were approved, motion by Downey seconded by Winks.

Architectural Control Committee (Doug Stewart)

Financial Statements

- Total Income for the month of April was \$252; total Expenses were \$3,738; Net Operating Income shows a deficit of (\$3,486). Year-to-Date shows a surplus of \$49,196 compared to a budgeted deficit of (\$4).
- Late fees are posted and notices are sent out after the 15th. Due to the delay in homeowners receiving their coupons, a late fee of 12% will be assessed for Annual dues in May. After May an additional 10% will be assessed on any unpaid balances. Member delinquencies: \$13,463. One homeowner remains in legal and owes \$3,181. Approximately 25 owners still owe their annual dues. Four owners have additional balances, three owing \$600 each and one owing \$405.

Review of Pinehurst website: Board feedback on Easysite

- After a motion duly made and seconded, the board has decided to move the email hosting for the community's email to Gmail
 - Motion by Stewart, seconded by Downey
 - This will happen over the next several weeks
 - Gmail is free whereas the current host (PowWeb) is over \$400 a year for both email and web hosting for the community.
- After a motion duly made and seconded, the board has decided to open an Easysite account and create a prototype website to evaluate the feasibility of moving the current hosting (PowWeb) of the Pinehurst website to this new host
 - This move would account for a cost savings of approximately \$320 a year.
 - The Easysite tools would allow for more flexibility/interactivity and opening up the site to more use by the HOA Committees.

Review of board historical hand-off material

There was a CD created about a year ago of some historical soft documents of the association.

- Ben will check Google Apps for Document storage
 - This will make sense as these services become available once the board email hosting is moved
- Plan is to get all the documents into a single point of access and allow for a cleaner and more complete handoff between transitioning board members.

New Business

There was discussion on communicating important information to the community throughout the year. The board is evaluating options.

• EMB offers a service involving 4 broadcast/flash messages to the community per year. The Board is evaluating the cost and benefits of using this service in the future
