2010 Budget

The board reviewed the final changes to the proposed budget for CY10. One change the board will make from last month's changes is to move \$1000 from the 'Community Events' to 'Replacement Deposit'. Motion to approve the budget with changes made by Mr. Downey and seconded by Mr. Long. The board discussed times for the budget ratification meeting. Mrs. Cole will discuss November 18th and December 2nd with Monroe Elementary. November 18th is the board's first choice.

Other Business

Board discussed times for the annual meeting next year. The board would like to notify home owners that 3 board positions will be opening up as the terms of Mr. Bourland, Mr. Downey, and Mr. Winks are ending.

Board discussed the painting of the pipeline fence this summer and the repair of the fence at the bottom of the community. These maintenance items will be discussed in more detail in a future meeting.

The Board set the date of their next scheduled meeting to follow the Budget Ratification meeting at Monroe Elementary School.
